**OFFICE OF THE DISTRICT MAGISTRATE, DARBHANGA**

**ORDER**

IN exercise of the power conferred upon me under sec 'A' of the sarai act- 1867 **PARUN PARSAD District Magistrate Darbhanga** do here by order that name of Smt. **RITA PRASAD**, D/o- Sri Nirsan Sah, Moh- Shahganj Benta, P.O.- Laheriasarai, P.S.- Laheriasarai, Dist- Darbhanga is registered as proprietor and keeper of Godavri Jeevachh <sup>Memorial</sup> Hospital & Research Centre, (as Sarai) Moh- Shahganj Benta, P.S.- Laheriasarai, Darbhanga on terms and condition laid down under section 7 of the Act 1867 as detailed below. The keeper shall be bound.

1. When any person in such Nursing Home (as Sarai) is ill or an infection or contagious disease or dies of such diseases to give immediate notice thereof to the nearest police station.
2. At all times when required by any magistrate or any person duly authorized by the magistrate of the district in the behalf to give him free access to Nursing Home (as sarai) and allow him to inspect the same are any part thereof.
3. To thoroughly clearness the room and verandah and drains of the Nursing Home (as Sarai) and the walls, tanks or other sources from which water is obtained for the person or animals using: to the satisfaction of and so often as shall be required by the magistrate of the dist. Or such person as he shall appoint in this behalf.
4. To remove all noxious vegetation on or near the Nursing Home as sarai and all trees and branch of trees capable of affording to thieves means of entering or leaving the Nursing Home (as sarai).
5. To keeps the gate, walls, fences roof and drains of the Nursing Home (as sarai) in repair.
6. To provide such number of watchman as may in the opinion of the magistrate of the dist....., subject to such rules as state Govt. may prescribe or vehicle lodging in halting at or placid in the Nursing Home (as sarai).
7. To exhibit a list charges for the use of the Nursing Home (as sarai) at such place and form and language as the Magistrate of the Dist. ~~Darbhanga~~ shall from time to time direct.
8. However this order is valid upto one year.
